

Right-Fit Training Model

Explaining the complex concepts contained in Jaques' Stratified System's Theory (SST) in a short amount of time and to people with a variety of learning styles, processing levels and backgrounds is a real challenge. My attempt to do so has led to my development of a hands-on/tactile and visual model which I call the right fit training model. Through its development some of the RO/SST language has been adapted, as well.

This presentation will demonstrate the Right-Fit Training Model for explaining basic Requisite Organization/SST principles of orders of information (I – IV only), types of processing (declarative, cumulative, serial, parallel), processing levels (CIP), trajectories and modes, time horizon (TH) and time-span-of-discretion (TSD). These concepts are then applied to the practical issues of person-job fit (P-J), person-superior fit and organizational structure based on processing levels. Other aspects of the person such as skilled-knowledge and character are also considered in the model in determining best P-J fit. The colors, shapes and tactile experience help people of all learning styles to grasp both the concepts and their implications for organizational design and practice. (*Partial drawing below*.)
